

## WARWICK RACECOURSE SPORTING ICON BRUNCH TERMS AND CONDITIONS

1. By entering the Sporting Icon Social Media competition at Warwick Racecourse (the "Competition"), the terms and conditions (as defined below), entrants agree to be bound by these Rules and your attention is specifically drawn to the conditions No. 10, No.13 and No. 18.
2. In the event of any dispute regarding the Rules, conduct, results and all other matters relating to the Competition, the decision of Warwick Racecourse shall be final and no correspondence or discussion shall be entered into.
4. The Competition is open to those aged 18 and over. Warwick Racecourse assumes that by reading the publication or by using the website and entering the Competition (and you warrant that) you are aged 18 or over.
5. Employees of Warwick Racecourse or any associated company of Warwick Racecourse and their immediate families, persons connected with the Competition i.e. prize sponsors, newsagents, wholesalers & their agents are not able to win the prize offered in the Competition.
6. By entering the Competition, you hereby warrant that all information submitted by you is true, current and complete. Warwick Racecourse reserves the right to verify the eligibility of all entrants.
7. Warwick Racecourse reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any of the Rules.
8. Only one entry per person per Competition is allowed, any entrant who enters more than the permitted maximum will be disqualified.
9. Where the winner has been selected and Warwick Racecourse discovers or has reasonable grounds to believe the winner has made more than one Entry, Warwick Racecourse reserves the right to select an alternative winner.
10. To enter the Competition, users must comment your entry on the Facebook post by Wednesday 17<sup>th</sup> October at 4pm.
11. Entries to the Competition will be open from 6pm on Thursday 11<sup>th</sup> October 2018.
12. Entries to the Competition must be made by the closing time of 4pm on Wednesday 17<sup>th</sup> October. Failure to do so will disqualify the entry.
13. Entrants should note that unless stated otherwise, Warwick Racecourse does not accept responsibility for the return of any Entries, including those consisting of artistic or other material.
14. Prize winners will be contacted via Facebook messenger on the day of the closing of the Competition, Wednesday 17<sup>th</sup> October 2018.
15. The winner will be selected at random by a Random Number Generator.
16. Confirmation of acceptance of the prize must be made by Friday 19<sup>th</sup> October at 5pm. Failure to claim a prize by 5:00pm on Friday 19<sup>th</sup> October 2018 will result in disqualification.
17. Competition prizes are non-transferable and there is no cash alternative. Warwick Racecourse reserves the right to substitute prizes of equal or greater value at any time.
18. Competition prizes are awarded at the discretion of Warwick Racecourse and no prizes will be awarded as a result of improper actions by or on behalf of any entrant.

Selling or transferring prizes includes, but is not limited to, selling and/or distributing on any website including any auction site whether it is operated by a third party or by a prize winner. You hereby warrant that your entry and all information which you submit and/or distribute will not infringe the intellectual property, privacy or any other rights of any third party, and will not contain anything which is libellous, defamatory, obscene, indecent, harassing or threatening. If relevant, Warwick Racecourse reserves the right, but not the obligation, to screen, filter and/or monitor information provided by you and to edit, refuse to distribute or remove the same.

21. Warwick Racecourse cannot accept any responsibility for any damage, loss, injury or disappointment suffered by any entrant entering the Competition or as a result of accepting any prize. Warwick Racecourse is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers, or providers, computer equipment or software, failure of any email or entry to be received on account of technical problems or traffic congestion on the Internet, telephone lines or at any web site, or any combination thereof, including any injury or damage to entrant's or any other person's computer or mobile telephone related to or resulting from participation in the Competition. Nothing shall exclude Warwick Racecourse's liability for death or personal injury as a result of its negligence.
